A basic tenet of GMP is that: quality cannot be tested into a batch of product; quality must be built into each batch of product during all stages of the manufacturing process.

All guideline follows a few basic principles : Manufacturing facilities must maintain a clean and hygienic manufacturing area. Manufacturing facilities must maintain controlled environmental conditions in order to prevent cross-contamination from adulterants and allergens that may render the product unsafe for human consumption or use.
