Authorizing Resolutions. Certificates of such resolutions in form and content as the Title Company may reasonably request evidencing Seller's existence, power and authority to consummate the transaction herein contemplated, including copies of all corporate organizational documents or other reasonable evidence of corporate authority.

## **Authorizing Resolutions Sample Clauses**

The corporation's secretary has the role of filing all corporate resolutions in the corporate records book. These resolutions don't need to be submitted to any governmental agency, but they must be available if the corporation is audited by the IRS or other agency, or by the business department in the state where the corporation is located.
